**Penalty Fee: 150,00€**

If the Lessee exceeds the maximum kilometers authorized by Ecomobile – Rent a Car, by Rental Contract, it will have to settle the additional kilometers by the extra kilometer value stipulated in the Particular Conditions. If the Lessor detects that the Lessee has left the Portuguese Continent without prior notice, that is, at the time the Rental Contract is executed and without the express written consent of the Lessor, the Lessee will have to settle a penalty fee.

**Penalty Fee: 250,00€**

If the Lessee exceeds the level contracted in the Rental Contract will have to settle the additional kilometers by the value of the extra kilometers stipulated in the Particular Conditions. If the Lessor detects that the Lessee has left the Portuguese Continent without prior notice, that is, at the time of the Rental Contract and without the express written consent of the Lessor, the Lessee will have to settle a penalty fee of 203, 25€ + Taxes = 250,00€.
